Centre Region Act 537
Sewage Facilities Plan
The Borough of State College and Townships of College, Ferguson, Halfmoon, Harri and Patton have prepared an update o the Centre Region Act 537 Sewage Facilities Plan. This notice is published to provide interested persons a 30-day public comment period to comment on the proposed Plan prior to adoption of the document by the aforementioned municipalities.
The Centre Region Act 537 Sewage Facilities Plan evaluates existing sewage facilities in the Centre Region, and identifies the community's future sewage disposal needs based on forecasted growth. The Plan provides an updated Sewer Service Area (SSA)/Regional Growth Boundary (RGB) which identifies areas where public sewer service will be provided by the University Area Joint Authority (UAJA). In addition an Implementation Agreement, which outlines a process for considering future requests to expand the RGB/SSA, is provided in the Plan Update. The Plan also identifies UAJA collection and conveyance system upgrades that will be needed to support future growth in the community, and provides costs and a time schedule for the completion of these upgrades. In addition, the Plan outlines a sewage management program which will be implemented in selected areas of the Region which utilize on-lot sewage disposal systems.
To provide interested parties the opportunity to review the Plan's recommendations, copies of the document are available for public inspection at the Centre Regional Planning Agency located at 2643 Gateway Drive, State College, PA 16801. Written comments on the Plan will be received at the CRPA Offices until 12:00 Noon on Friday, October 20, 2006. All written comments received during the 30 day public
